THIS BODY REIGNS INGLORIOUSLY, SHAMELESSLY AND IGNOBLY OVER THE WRECKAGE NEFARIOUSLY WROUGHT BY THE FORMER HANDS OF THE CAUSE OF THE DIVINELY-CONCEIVED ADMINISTRATIVE ORDER BEQUEATHED TO US BY 'ABDU'L-BAHÁ, DECLARING THIS ORDER NOW DEFUNCT AND THE GUARDIANSHIP OF THE FAITH ENDED FOR ALL TIME.

The body referred to above is the sans-Guardian and hence headless, illicitly formed and illegitimate Universal House of Justice, with its seat in Haifa, the election of which first took place at Ridván 1963.

The wreckage of the divinely-conceived Bahá'í Administrative Order and the man-made substitute organization over which this so-called Universal House of Justice now presides is the tragic result of the following inexcusable **multiple failures** on the part of the former Hands of the Cause immediately following the passing of Shoghi Effendi in their first conclave held in 'Akká from 18-25 November, 1957.
